On 18 February the winners of the 2014 Student Design Competition “Integrated Communities: A Society for All Ages” will be announced and projects presented during the “Cities of Tomorrow: Inclusion, Technology, Arts and Resources” High-Level Session at United Nations Headquarters. Students are from schools of architecture in 7 countries: Brazil, China, Italy, Italy (project in Istanbul, Turkey), Ireland, Kosovo, Sudan, United Kingdom (project in Indore City, India).

The Competition has been organized by the International Council for Caring Communities in support of the 7<sup>th</sup> World Urban Forum to be held in Medellin, Colombia, 5-11 April 2014 and the MDGs. This Competition was established in 1994 in support of Habitat II as a bridge between research and practice endeavoring to prepare the next generation of students with the tools essential to enhance the quality of life for the fast growing “graying society.” Over 8,000 students from more than 50 countries have participated in the competitions.
