He recognizes that there are wide disparities throughout the world and is devoted to help closing the gap as much as possible.

#### Professor Dianne Davis, President and Founder, International Council for Caring Communities, ICCC

Professor Dianne Davis, since 1966 cited in "Who's Who of American Women", is founding president, International Council for Caring Communities (ICCC) established in 1993. It is a non-profit organization accredited to the UN Economic and Social Council. The book, Hospitable Design for Healthcare and Senior Communities, written with Dr. Albert Bush-Brown, initiated the "Better living...Adding Life to Years" programs. To stimulate greater understanding her efforts include: The "Cross-Sectoral" Windsor Consultations, "Integrated Communities: A Society for All Ages" Student Competitions, and events addressing interaction of ICT, disability, health and rehabilitation. Professor Davis fosters new mindsets and develops products and services for the hospitality, healthcare and educational industries.

Known as an industry catalyst, change agent, and futurist, her goal is to develop "cross over" ventures and stimulate traditional "sleeping" organizations to move into the forefront of performance and impact.

# Ms. Akiko Ito, Chief of the Programme on Disability/Secretariat, United Nations

Ms. Akiko Ito is Chief of the Programme on Disability/Secretariat for the Conference on the Convention on the Rights of Persons with Disabilities and UN/Focal Point on Disability, Department of Economic and Social Affairs. She was in charge of the Secretariat for the United Nations General Assembly Ad Hoc Committee on an international Convention on the Rights of Persons with Disabilities and thereafter the Secretariat for the Convention on the Rights of Persons with Disabilities. The focus of her office has been to mainstream the goals and the objectives of the Convention in the global agenda, including in the context of the 2030 Development Agenda for Sustainable Development with an emphasis on the inclusion of "the furthest left behind," in particular as it pertains to the leadership of women and girls with disabilities in the SDG implementation and its monitoring and evaluation. She has served the Department of Economic and Social Affairs as a Focal Point for Women and Rule of Law as well as for the Human Rights Mainstreaming for the United Nations Development Group.

She has been a founding member/co-chair of the United Nations Inter-agency Support Group on the Convention on the Rights of Persons with Disabilities and the past president of the Board of the United Nations Partnership on the Rights of Persons with Disabilities. She has served under a number of mechanisms for the UN internal justice system related to diversity, gender equality and, in particular, the inclusion of persons with disabilities at the United Nations.

Ms. Ito has extensively lectured and published on issues concerning disability and human rights at the United Nations. Previous to her current post, she worked in the Legal Affairs Section of the United Nations Drug Control Programme in Vienna, Austria. She also served under the United Nations Observer Mission in South Africa. Her academic background is international law and the area of interest is domestic application of international law, with a focus on the rights of the minorities and the disadvantaged groups.

Ms. Ito has an LL.B. in International Legal Studies from Sophia University, Tokyo, Japan, M.A. in International Relations from the University of Chicago and LL.M. from the School of Law, University of California at Berkeley.

#### Dr. Cecilia Martinez Leal, Board Chair of the World Resource Institute WRI, Mexico

Is currently Board Chair of the World Resource Institute WRI, Mexico; she is Board Member of Habitat for Humanity Mexico and presides the Board for Place Making Mexico.

Retired in 2013, Dr. Martinez is former director of the UN-Habitat Office in New York. She has ample experience in housing, urban planning and urban design, working with communities, private sector, academia and national and local governments in Latin America. She holds a PhD degree in Urban Design from Oxford Brookes University, Oxford, England and has a graduate degree in Architecture from the Universidad Iberoamericana in México City. Before joining the NYC office, Martinez served as the director of UN-HABITAT for the Latin America and the Caribbean Office, based in Rio de Janeiro, Brazil (2007-2011) and as the director of UN-HABITAT Mexico in Mexico City (2004-2007). From 2003-2004, she was the Director of the Association of Public Private Sector Programme at the Ministry of Social Development in Mexico. Martinez had held several other positions during her career including: Member of the Platform of Social Organizations for Mexico city, Council member for FINCOMUN, founder of a Microenterprise Association (NGO) Mexico, professor for Planning and Urban Design at the National University of Mexico, advisor to the director of Housing and Urban Development and the Undersecretary for Urban Development (Federal Government) SAHOP.
